The Smyrna School District is providing a wraparound program for students in grades kindergarten to sixth grades. The district has partnered with the Boys and Girls Club of Delaware to provide the staff and program framework for learning recovery before and after school in our six schools housing kindergarten to sixth grades. The district is hiring Wraparound Curriculum Coaches to provide high quality instructional materials, training and support to the Boys and Girls Club staff for the site based model housed in our schools and the club located in our community. In addition, the coaches are committed to providing curriculum, support and materials to local daycare centers where our students attend. This program is a yearlong attempt to extend the school day and increase the capacity for learning of our students who lost in person instructional time during the pandemic. Our coaches are meeting in as a district team to identify students attending the programs and specific need areas. Meeting as a district team we will review these needs identify supports and reach out to the Boys and Girls Club with resources. Throughout the year we will continue to monitor progress, student data, their interventions and the supports we provide.

The district will use ARP ESSER Funds to support needed upgrades to our existing heating, ventilation, and air conditioning (HVAC) systems at select locations.

- Our Central Plant is a building that houses HVAC equipment that is responsible for controlling the environment at our middle and high schools. This equipment has the capability to impact greater than 2,900 staff and students and is currently in need of refurbishment to operate at 100% efficacy
 - The design and operation of our high school fresh air system is antiquated. This system has the capability to impact over 1,800 students and staff. It is also in need of refurbishment to operate at 100% efficacy
- It is essential for HVAC systems to operate as expected in order to mitigate the risks associated with the spread of COVID-19 in buildings (schools).
